4 FIRST-AID MEASURES

GENERAL INFORMATION Move the exposed person to fresh air at once. Get medical attention if any discomfort continues.

INHALATION

Move the exposed person to fresh air at once. When breathing is difficult, properly trained personnel may assist affected person by administering oxygen. Perform artificial respiration if breathing has stopped. Keep the affected person warm and at rest. Get prompt medical attention.

INGESTION

NEVER MAKE AN UNCONSCIOUS PERSON VOMIT OR DRINK FLUIDS! Drink plenty of water. DO NOT induce vomiting. Get medical attention immediately.

SKIN CONTACT Remove affected person from source of contamination. Promptly wash contaminated skin with soap or mild detergent and water. Promptly remove clothing if soaked through and wash as above. Get medical attention if irritation persists after washing.

EYE CONTACT Promptly wash eyes with plenty of water while lifting the eye lids. Continue to rinse for at least 15 minutes and get medical attention.

5 FIRE-FIGHTING MEASURES

EXTINGUISHING MEDIA Use: Water spray, fog or mist. Alcohol resistant foam. Carbon dioxide (CO₂). Dry chemicals, sand, dolomite etc.

SPECIAL FIRE FIGHTING PROCEDURES

Keep run-off water out of sewers and water sources. Dike for water control. Cool containers exposed to flames with water until well after the fire is out. Move container from fire area if it can be done without risk. Use water spray to reduce vapours. If risk of water pollution occurs, notify appropriate authorities.

UNUSUAL FIRE & EXPLOSION HAZARDS

May explode in a fire. May form explosive or toxic mixtures with air. May explode when heated or when exposed to flames or sparks. May travel considerable distance to source of ignition and flash back. Vapour explosion and poison hazard indoors, outdoors and in sewers.

SPECIFIC HAZARDS Fire creates: Carbon monoxide (CO). Carbon dioxide (CO₂).

6 ACCIDENTAL RELEASE MEASURES

PERSONAL PRECAUTIONS

Wear protective clothing as described in Section 8 of this safety data sheet.

ENVIRONMENTAL PRECAUTIONS Prevent entry into drains.

SPILL CLEAN UP METHODS

Ventilate well, stop flow of gas or liquid if possible. Remove ignition sources. Do not allow chemical to enter confined spaces such as sewers due to explosion risk. Sewers designed to preclude formation of explosive concentrations of vapour may be permitted. Extinguish all ignition sources. Avoid sparks, flames, heat and smoking. Ventilate. Provide ventilation and confine spill. Do not allow runoff to sewer. Absorb in vermiculite, dry sand or earth and place into containers. Avoid contact with skin or inhalation of spillage, dust or vapour. Clean-up personnel should use respiratory and/or liquid contact protection.

7. HANDLING AND STORAGE

USAGE PRECAUTIONS

Keep away from heat, sparks and open flame. Avoid spilling, skin and eye contact. Ventilate well, avoid breathing vapours. Use

approved respirator if air contamination is above accepted level. Wear full protective clothing for prolonged exposure and/or high concentrations. Static electricity and formation of sparks must be prevented.

STORAGE PRECAUTIONS

Flammable/combustible - Keep away from oxidisers, heat and flames. Store in tightly closed original container in a dry, cool and well-ventilated place. Protect from light, including direct sunrays. May attack some plastics, rubber and coatings. Ground container and transfer equipment to eliminate static electric sparks.

PROTECTIVE EQUIPMENT

Eye protection :goggles Hand protection: gloves

ENGINEERING MEASURES Provide sufficient ventilation during operations which cause vapour formation.

RESPIRATORY EQUIPMENT If ventilation is insufficient, suitable respiratory protection must be provided. Chemical respirator with organic vapour cartridge.

HAND PROTECTION

Use suitable protective gloves if risk of skin contact. Use protective gloves made of: Butyl rubber. Neoprene. The most suitable glove must be chosen in consultation with the gloves supplier, who can inform about the breakthrough time of the glove material.

EYE PROTECTION Wear splash-proof eye goggles to prevent any possibility of eye contact.

OTHER PROTECTION Wear appropriate clothing to prevent any possibility of liquid contact and repeated or prolonged vapour contact. Provide eyewash station.
